- Anglin gave update on Logic and Accuracy Testing of the equipment for the upcoming election and that it has been completed.
- Poll Worker training has been conducted with 44 workers trained.
- Anglin reviewed number of absentee ballots issued and received to date.
- Anglin indicated that the Civic Center would be the location for all advance voting for the remainder of 2021. All members spoke that they agree it should stay there and that the voters like the location.
- Voter registration totals were given. As of 2/24/2021, Oconee County has 31965 total voters - 30558 active and 1407 inactive voters. Shook asked about the inactive voter rolls and was told that the process would happen later in the year.
